

**GATES COUNTY BOARD OF COMMISSIONERS
REGULAR MEETING MINUTES
JULY 1, 2013**

The Gates County Board of Commissioners met in Regular Session at 5:00 p.m. Monday, July 1, 2013 in the main courtroom, 202 Court Street, Gatesville. Commissioners Jordan, Owens, Hora, Jernigan and Hofler were present. Also present was County Manager, Jon Mendenhall.

Chairman Jordan led in prayer and the pledge of allegiance.

Chairman Jordan called the meeting to order.

Approval of Minutes

Commissioner Owens made a motion to approve the June 5, 2013 Meeting Minutes as amended. Commissioner Hofler seconded the motion, motion carried without opposition.

Approval of Agenda

Commissioner Owens made a motion to approve the Agenda as presented. Commissioner Hofler seconded the motion, motion carried without opposition.

Delegations – Unannounced

Reba Green-Holley, Cooperative Extension Director, invited the Board to the annual Commissioners luncheon on August 7. She also invited the Board to attend and serve at the employee luncheon on July 9.

Delegations – Announced

Esther Lassiter, Gates Partners for Health, stated her organization has applied and received a \$25,000 grant for a comprehensive diabetes plan funded by the Obici Healthcare Foundation. Carolyn Allison, CEO, Gateway Community Health Center, discussed the key points of the diabetes program. Funding from the Obici Healthcare Foundation totals \$155,093.

Mr. Lee Riddick, Chairman, Gates County Housing Committee, discussed the completion of the Gates County Housing Assessment and Action Plan.

Administrative Reports

Jon Mendenhall, County Manager, presented the June Administrative Report.

Renee McGinnis, Tax Administrator, presented the June Tax Collector's Report and the 2012-2013 Close-Out Report.

New Business

Mr. Mendenhall presented a request to hold a public hearing on an ordinance to regulate nuisances.

Mr. Owens made a motion to schedule a public hearing on an ordinance to regulate nuisances. Commissioner Hofler seconded the motion, motion carried without opposition.

Mr. Mendenhall presented a request to hold a joint meeting with the Town of Gatesville. This joint meeting will be at the end of the meeting on August 7.

Mr. Mendenhall presented a request to hold a work session to review the Emergency Management/disaster preparedness plan. This work session will be held at 6:00 p.m., July 15, prior to the regular Commissioners' Meeting.

Commissioner Owens made a motion to enter Closed Session authorized by NCGS §143-318.11(1)(4) Economic Development, (a)(6) Personnel. Commissioner Jernigan seconded the motion, motion carried without opposition.

Commissioner Owens made a motion to exit Closed Session and enter Regular Session. Commissioner Hofler seconded the motion, motion carried without opposition.

Commissioner Owens made a motion to move forward with Phase II as directed in Closed Session. Commissioner Jernigan seconded the motion, motion carried without opposition.

Commissioner Hofler made a motion to authorize the County Manager to send certified correspondence as directed in Closed Session. Commissioner Jernigan seconded the motion, motion carried without opposition.

Commissioner Jernigan made a motion to authorize a (6) month housing extension for the County Manager. Commissioner Hofler seconded the motion, motion carried without opposition.

Commissioner Hora made a motion to authorize the County Manager to move forward with reorganization identified as items 2, 3 and 4 as discussed in Closed Session. Commissioner Owens seconded the motion, motion carried without opposition.

Commissioner Hora made a motion to recess until July 15, 2013. Commissioner Owens seconded the motion, motion carried without opposition.




